

At a regular meeting of the Pulaski County Board of Supervisors held on Monday, November 25, 1991, at 7:00 p.m. in the Board of Supervisors Meeting Room of the County Administration Building, 143 Third Street, N. W. in the Town of Pulaski, the following members were present: Mason A. Vaughan, Sr., Chairman; Jerry D. White, Vice-Chairman; Bruce L. Fariss; Joseph L. Sheffey; and V. E. Vaughn. Chairman Vaughan welcomed Supervisor-Elect Ira S. "Pete" Crawford to the meeting.

1. Invocation

The invocation was delivered by County Attorney Thomas J. McCarthy Jr.

2. Public Hearings

a. Proposed Six Year Secondary Road Improvement Plan

The Chairman opened a public hearing on the proposed plan. Virginia Department of Transportation Resident Engineer, who was assisted by department employees Greg Nester and Pete Miles, conducted the hearing. Mr. Brugh indicated that on the plan proposed Route 607 debt payment should be listed as project number one.

It was moved by Dr. Fariss, seconded by Mr. Sheffey and carried, that the following resolution be adopted:

WHEREAS, the Board of Supervisors of Pulaski County, in cooperation with representatives of the Virginia Department of Transportation, have prepared a proposed Six-Year Plan for Pulaski County listing improvements proposed on the State Secondary Highways System in Pulaski County for which funds are to be budgeted in fiscal year 1992-98, and

WHEREAS, a duly advertised public hearing was conducted at the County Administration Building in Pulaski, Virginia at 7:00 p.m. on November 25, 1991, for purposes of informing interested citizens of the proposed Six-Year Plan and for soliciting public input into the planning process in accordance with Section 33.1-70.01 of the Code of Virginia of 1950, as amended; and

WHEREAS, this Board has given due consideration to such input and other factors pertaining to improvement of the State Secondary Highways System in Pulaski County.

NOW, THEREFORE BE IT RESOLVED the Board of Supervisors of Pulaski County hereby approves the aforementioned Six-Year Plan for improvement of the State Secondary Highways System in Pulaski County for fiscal years 1992-98.

Also approved was the priority listing for addition to the six year plan, a copy of which is included with the records of this meeting, as well as charts for the six year plan priority listing and the priority listing for additions to the six year plan.

b. New River Sewerline Extension Bond Resolution Public Hearing

The Chairman opened a public hearing on the New River sewerline extension, which public hearing is being reheld due to an advertising oversight. No public comment was heard. The Chairman closed the public hearing.

It was moved by Mr. Sheffey, seconded by Mr. White and carried, that the following two resolutions be adopted:

New River Sewerline Extension Bond Resolution

WHEREAS, by resolution adopted on August 27, 1990 (the "Bond Resolution"), the Board of Supervisors of Pulaski County, Virginia (the "Board of Supervisors") authorized the issuance, sale, detail and payment of a \$212,600 sewer revenue bond (the "Bond").

WHEREAS, since the adoption of the Bond Resolution, the Public Finance Act (Chapter 5, Title 15.1, Code of Virginia, as amended) has been repealed and the Public Finance Act of 1991 (Chapter 5.1, Article 15.1, Code of Virginia of 1950, as

c. Reassessment Schedule

The Chairman opened a public hearing on an ordinance to establish a schedule for the operation of the Board of Equalization. No public comment was heard. The hearing was closed.

It was moved by Dr. Fariss, seconded by Mr. White and carried, that the following ordinance be adopted regarding the activities of the Board of Equalization and the following schedule for conduct of the reassessment also be adopted:

REASSESSMENT ORDINANCE

Be it ordained pursuant to Section 58.1-3378 of the 1950 Code of Virginia, as amended, that the Pulaski County Board of Supervisors does establish the following dates regarding the current reassessment of real estate in Pulaski County:

1. The date by which applications must be made by property owners or lessees to the Board of Equalization for relief from the proposed real estate assessment values effective on January 1, 1992, will be Monday, February 17, 1992.
2. The Board of Supervisors does also establish the deadline by which all applications for relief from the Board of Equalization must be finally disposed by the Board of Equalization as Friday, March 13, 1992.

This ordinance is take effect immediately upon adoption.

d. G. C. Harry Plat Vacation Request

It was announced that Mr. G. C. Harry has withdrawn his request for consideration of the plat vacation. Therefore, no public hearing was held; however, comments from the interested public were received.

The following citizens expressed concern regarding the proposal to vacate the plat and limit access along the road between Beach Road and lots 19 and 20 of the Claytor Lake Estates Subdivision: Gary Buckner; Larry French who presented petitions and represented the concern on behalf of the Snowville Volunteer Fire Department for access to the lake for fire fighting water; Curtis Hurst; John Crute; Ted Cox; Betty Hines; Frances Spencer; and Gwen Jones.

Supervisor White requested staff advise all known owners of lots in Claytor Lake Estates Subdivision should additional requests for plat vacations within the subdivision occur.

Supervisor White requested the County Attorney review the relationship between the Subdivision Ordinance plat vacation authorization and deed restrictions for access to the water in subdivisions such as Claytor Lake Estates, with particular reference to Deed Book 150, page 232, in the Circuit Court Clerk's Office.

3. Highway Matters

Resident Engineer J. D. Brugh met with the Board and discussed the following matters:

a. Transportation Funding Response

It was moved by Mr. White, seconded by Mr. Vaughn and carried, that the recommendations of the county administrator regarding the initiatives proposed by Secretary of Transportation Milliken be adopted, a copy of which recommendations are included in the records of this meeting.

b. Request for Paving of Tabor Place - Route 762

It was moved by Dr. Fariss, seconded by Mr. Sheffey and carried, that the request for paving of Route 762, Tabor Place, be added to the end of the Supervisors priority list for addition to the six year plan.

c. 2010 Highway Plan

The administrator reviewed for the Board the proposed 2010 highway plan as developed by the Virginia Department of Transportation.

It was moved by Dr. Fariss, seconded by Mr. Sheffey and carried, that the Board oppose a priority on a second bridge crossing New River at Radford coming prior to a new bridge crossing the New River in the Belspring area to provide a connection between the greater Blacksburg community, including the Virginia Tech campus, and the New River Valley Airport in the greater Dublin area, including Routes 100 and 81 near Dublin.

d. Rural Addition Right-of-Way Acquisition

Discussion was held to clarify the status of rural addition right-of-way acquisition. Mr. Brugh indicated \$60,000 was currently available for construction of rural additions.

The staff was requested to report at the December 16th meeting on the status of efforts to acquire rural addition.

It was moved by Mr. White, seconded by Dr. Fariss and carried, that a letter be sent to the residents of the rural addition off of Brookmont Road, Ms. Miller and Mr. Dalton, with a courtesy copy to Supervisor White indicating that should both these citizens not be willing to indicate agreement to donate right-of-way for this rural addition prior to the December 16th Board of Supervisors meeting, then that the project be placed on a lower priority, with available funds reallocated to other roads.

Supervisor Fariss requested the availability of right-of-way for the Allisonia rural addition off of route 693 and the Haga Drive rural addition be reported at the December meeting. Included in the report on rural addition right-of-way acquisition should be a listing of when each pending rural addition request was made.

e. Other Matters

Chairman Vaughan agreed to determine community interest on lowering speed limit on Route 643.

Supervisor Vaughn requested safety improvements, possibly a guardrail, at the intersection of Route 672 and the old Route 100.

Supervisor Vaughn requested a preliminary speed study for Route 788 and Route 644.

Supervisor Sheffey requested review of warning signs for Fairlawn Volunteer Fire Department highway entrance. Mr. Brugh agreed to investigate.

Supervisor Sheffey requested a directional sign for the Belspring Community Center. Mr. Brugh will provide.

Supervisor White was briefed on status of Thaxton Road drainage improvements and again requested attention to pavement deterioration on Alum Spring Road past Tyson Hills Subdivision.

Supervisor Fariss was advised it was too costly to install warning signals at the Dublin Fire Department entrance to Route 11.

Supervisor Fariss requested guardrail along Route 693 at the Big Reed Island Creek bluff. Mr. Brugh agreed to investigate.

An unidentified citizen inquired regarding improvements to the bridge crossing of the Little River at Snowville. Mr. Brugh indicated that the Virginia Department of Transportation plans to maintain the bridge but not increase its capacity.

4. Citizen Comments

Comments were made by Mr. Colbern Linkous, Mr. Morris Dawson and Mr. William G. Wall, II.

5. Treasurer's Report

Treasurer Rose Marie Tickle presented her monthly report.

6. Left Blank Intentionally

Item 6 was left blank intentionally to accommodate an orderly preparation of supplementary information to members to the Board of Supervisors regarding the agenda.

7. Reports from the County Administrator and Staff:

a. Cable Television Service - Dunkard's Bottom

It was moved by Mr. White, seconded by Dr. Fariss and carried, that representative of both cable TV franchises serving the county be requested to appear at the December Supervisor's meeting and review service improvements and rate increases for the past five years. It was also requested that Adelphia Cable Communications explain the denial of service extension in the Dunkard's Bottom area as requested by Mr. Don Hawkins.

It was moved by Dr. Fariss, seconded by Mr. White and carried, that the Board seek authorization from the General Assembly to allow de-franchising of cable television companies.

b. Brookmont Waterline Extension Financing

The Supervisors were briefed on the current status of bids received for the project and on the need to satisfy the debt reserve requirements of the original Farmers Home Administration loan before receiving authorization to award bids. A

more detailed report on this matter is scheduled for presentation at the Supervisor's December 16th meeting.

c. Little River Scenic Status

The staff was requested to schedule a presentation by Mr. Gibbons of the Virginia Department of Conservation and Historic Resources and Ms. Coyle of the New River Valley Preservation League at an upcoming Supervisor's meeting on both the Little River and Big Reed Island Creek/New River scenic status possibilities.

d. Meeting with Legislators on Upcoming General Assembly Issues

The staff was requested to invite Senator Marye and Senator-Elect Trumbo and Delegate Baker to the January 6th Supervisor's organizational meeting, with an alternate date for a meeting with the legislators to be December 16th. The purpose of the meeting is to discuss upcoming issues and the 1992 General Assembly that would effect county government.

e. Scheduling of Organizational Meeting and Joint Meeting with School Board

The staff was requested to arrange a swearing in of the new Board of Supervisors that will take office in January by the Circuit Court Clerk at the December 16th Supervisor's meeting. It was the consensus of the Board and Supervisor-Elect Crawford to schedule an organizational meeting and a joint meeting with the School Board for 7:00 p.m. on Monday, January 6, 1992.

The County Attorney was requested to contact Circuit Court Clerk Lookabill regarding meeting at the December 16th Supervisor's meeting for swearing in the new Board and taking care of other appropriate qualification activity.

f. Review of Private Shooting Range - Snowville Area

The County Attorney reported on the matter including a report of a site visit by Sheriff Dobbins and himself. It was determined that compliance with zoning or advice on civil remedies be pursued to assist the citizen aggrieved by the private shooting range.

8. Items of Consent:

It was moved by Dr. Fariss that an additional Christmas holiday of one day per employee be scheduled which could be alternated between either December 26 or December 27, 1991, as long as staffing of the offices for convenience to the public was made available on both dates. d. Courthouse Expansion Schedule

The following recommendations from the Courthouses Committee were approved:

The Board of Supervisors authorized engaging architect Thomas A. Douthat, Jr. for architectural and engineering services needed to complete the courthouse improvements, subject to the fees for those services being within the budget for the proposed bond issue and generally along the lines previously approved by the Board of Supervisors for the entire project.

Architect Douthat is to be requested to review resources available through the center for state courts in Williamsburg to aid in design of the courtroom and related offices.

The County Administrator is authorized to proceed to procure a financial advisor, if needed, and other assistance for issuance of the \$2.9 million courthouse improvements bond issue.

A subcommittee for the brick courthouse renovation and expansion was designated to assist the Courthouses Committee to be composed of Judge William Thomas, the Clerks of both the Circuit Court and the combined General District/Juvenile and Domestic Relations Court, a representative of the Sheriff's Department and Architect Douthat. The County Attorney offered to provide a staff liaison to this committee at no expense to the county.

The County Administrator was authorized to engage assistance for internal furnishings consultants services for the old courthouse, as recommended by a subcommittee working on this matter composed of the Commissioner of Revenue and Treasurer.

Overall, this schedule was accepted for occupancy of the renovation and expanded brick courthouse by mid 1993, with award of contract for construction by mid 1992, bidding during May 1992, completion of design by April 1992 and completion of committee input on original concept by January 1992.

The County Administrator was authorized to proceed to obtain final alternatives for the Board of Supervisors review on additional parking in the downtown area to support the courthouse complex, with such decisions to be made prior to the expiration of options on the temporary parking lots in February 1992.

e. 1991 Christmas Holiday Schedule

The Board authorized observing additional holidays declared by the Commonwealth for the Christmas season on Thursday, December 26 and Friday, December 27 1991, as well as a closing of offices at 3:00 p.m. on Tuesday, December 24th in recognition of Christmas Eve.

f. Contract Approval/Change Order

The Board of Supervisors accepted a recommendation from the Administrator to include a formal approval of any contract entered, amended or changed by recording of such in the minutes through placing the items on the consent agenda. The staff was authorized to proceed with this formal approval being included in the minutes effective for such procurements effective after July 1, 1991.

g. Appointments:

Action on appointments were deferred until following an executive session; however, the Board of Supervisors requested the staff provide each member of the Board and Supervisor-Elect Crawford with a list of all appointments to be made by the Board during any time period, including the expiration date for current appointees.

h. NRRRA Landfill Area Protection Policy

The NRRRA staff advised no update on this matter was available. The matter is to be scheduled for review again at the December 16th Supervisor's meeting.

i. Magnox Sludge Land Application Agreement

No report was made on this matter. The item is to be scheduled for the December 16th Supervisor's meeting.

j. Resolution - 50th Anniversary of the Attack on Pearl Harbor

The following resolution was adopted:

WHEREAS, on December 7, 1941, without military provocation, Japanese armed forces attacked American installations at Pearl Harbor, Hawaii; and

WHEREAS, that attack killed 2,403 American military personnel and wounded 1,178 others; and

WHEREAS, the attack on Pearl Harbor carried our Nation into World War II, where another 289,728 lives were lost, including the lives of 10,342 Virginians; and

WHEREAS, Americans fought and died to help defeat the forces of tyranny and to secure the blessings of freedom for millions of people throughout the world; and

WHEREAS, the immeasurable and unselfish sacrifices of those who died at Pearl Harbor and elsewhere during World War II deserves our highest honor and praise;

NOW, THEREFORE, be it resolved that the Pulaski County Board of Supervisors hereby recognize December 7, 1991, as the 50th Anniversary of the attack on Pearl Harbor and call its significance to the attention of all our citizens.

k. Hiwassee School Building Possible Use as a Rescue Station

The Emergency Services Coordinator was requested to confer with the Pulaski County Rescue Life Saving Crew to reconsider the proposed plan for use of the former Hiwassee school building as a rescue squad station, with consideration being given for the squad station to be located in the classroom area of the building in order to reserve the cafeteria and multipurpose meeting area of the building for general public use.

I. Memorial Resolution - Robert S. Love

MEMORIAL RESOLUTION
ROBERT H. LOVE

WHEREAS, the Pulaski County Board of Supervisors has repeatedly called upon the services of Robert H. Love as:

a member of the Board of Directors of the Pulaski County Public Service Authority; and

a member of the Pepper's Ferry Regional Waste Water Treatment Authority; and

WHEREAS, Robert H. Love met that call by serving:

as the only Chairman of the Public Service Authority Board of Directors; and

as the only Chairman of the Pepper's Ferry Regional Waste Water Treatment Authority.

WHEREAS, Robert H. Love has guided the development of water and sewer utility facilities in Pulaski County from their infancy, through design, construction, and expansion; and

WHEREAS, Pulaski County is generally superior to those utilities available to rural citizens in the Commonwealth Virginia and the nation; and

WHEREAS, the contribution made by Robert H. Love has benefited not only present and past citizens of Pulaski County, but will enhance the quality of life of its future citizens; now therefore

BE IT RESOLVED, that the Pulaski County Board of Supervisors hereby commend and express its appreciation for the service of Robert H. Love to the county and its citizens; and

BE IT FURTHER RESOLVED, that this Board of Supervisors does extend to the family of Robert H. Love its condolences in his passing; and

BE IT FURTHER RESOLVED, that the text of this resolution be spread on the minutes of the Board of Supervisors in testimony of its appreciation to the service provided by Robert H. Love to the citizens of Pulaski County.

m. NRRRA Moral Obligation for Additional Financing

The following resolution was adopted:

WHEREAS, the City Council of the City of Radford, Virginia, the Town Council of the Town of Dublin, Virginia and the Board of Supervisors of Pulaski County, Virginia, created the New River Resource Authority (the "Authority") by joint resolution pursuant to the Virginia Water and Sewer Authorities Act, Chapter 28, Title 15.1 of the Code of Virginia of 1950, as amended (the "Act"); and

WHEREAS, the Authority purchased and developed an interim landfill facility located in the City of Radford, Virginia (the "City") through a \$2,326,000 line of credit/term loan facility, subsequently increased in the amount of \$200,000, evidenced by notes (the "Original Bond") from the Authority to Sovran Bank, N.A., Pulaski, Virginia (the "Credit Institution"); and

WHEREAS, the Authority issued its bonds in August 1990 in the amount of \$4,000,000 (the "Bonds") to refund the principal indebtedness of the Original Bond

and finance (i) the expansion of the interim landfill facility, (ii) the engineering and construction of a yard waste composting facility and (iii) the engineering, design and permitting of a permanent landfill; and

WHEREAS, the Authority now desires to obtain temporary financing in order to pay (1) the cost of certain construction of the southern expansion at Ingles Mountain landfill, (2) the option price for certain property known as the Matson property, (3) scale automation and (4) closing costs (clauses (1) through (4) being collectively referred to hereinafter as the "Project"); and
