

At a reconvened meeting of the Pulaski County Board of Supervisors held on Thursday, June 18, 1992, at 7:00 p.m., in the Board of Supervisors Meeting Room of the Pulaski County Administration Building, the following supervisors were present: Jerry D. White, Chairman; Joseph L. Sheffey, Vice-Chairman; Mason A. Vaughan, Sr.; Ira S. "Pete" Crawford; and Dr. Bruce L. Fariss.

The county administrator was present, as well as Southwest Times Reporter Dee Ann Lindsey and Roanoke Times Reporter Paul Dellinger.

The Chairman opened the meeting and explained the purpose of the meeting was to interview candidates for appointment to fill the vacancy on the county School Board from the Robinson District.
