SUBJECT: Public Hearings

- a. Request from Jerome and Hazel Taylor to vacate plats and close an alley between lots identified on Pulaski County tax maps as map numbers 38-1-192, 192A, 193, 227, & 228A, in the New River community, Cloyd District, of Pulaski County - See enclosed correspondence and map showing the proposed alley to be vacated and discontinued. Discontinuing the alley would allow the Taylors to utilize the alleyway exclusively.
- b. Consideration of an ordinance to renew the cable TV franchise of Adelpia Cable Communications which may include an extension of the current franchise for up to

three months during review of the franchise renewal terms - See enclosed ordinance requested by Adelphia Cable Communications. The staff is presently not ready to recommend the terms of the franchise renewal, but suggests a three month extension to allow further review. Issues that would benefit from further review include: provisions for wiring public buildings, schools, fire and rescue stations, and hospitals; renewal term of five versus fifteen years; clarification of Section 4-C, Terms for Service Refusal; adequacy of past service and capability to continue service; and adjustment for recent changes in federal law governing cable communications.

c. Zoning Text Amendments to Allow Setback Variance - Industrial Zones - Approval of the enclosed is recommended by the Planning Commission.

d. Rezoning of Property Owned by Robert Smith, identified on Pulaski County tax records at parcel #047-17-BK3-4, 5, & 6, located east of Dublin in the Oakwood Subdivision off Rt. 11, Lee Highway, proposed change from Residential (R) to Residential (R2) in the Ingles District - See enclosed background information and a recommendation for approval by the Planning Commission.

e. Conditional Use Permit for Quarrying for Radford Limestone Corporation property off Little River Dam Road, Rt. 605, Ingles District, tax map parcels #068-1-1&2A - See enclosed background information and recommendation from Planning Commission that the conditional use permit be issued.

f. Request By Ward Angle, Trading As Precision Docks, To Re-zone Tax Map Parcel Number 68-1-20, 23, 34 From Agricultural (A-1) To Conditional Industrial (I-1), as well as a site plan for a sea wall and piling installation building and outdoor storage, to be located on Rt. 605, Little River Dam Road - With the Planning Commission making a recommendation on the Radford Limestone property, it would now be appropriate for the Board to review its deferral of action on the request by A/B Enterprises for a conditional industrial zoning to allow the company's dock building business to locate and expand on the existing property used by the business. SUBJECT: Highway Matters

a. Follow-up from September 21 mtg.

1. Flashing crossing lights in the vicinity of Riverlawn School - Mr. Bob Pritchett requested the flashing lights previously installed in this area be replaced. Supervisor Sheffey indicated plans are to restore the flashing lights. The resident engineer is requested to confirm.
2. Brush trimming at Pepper's Ferry Loop, Rt. 695 - Supervisor Sheffey indicated this work had been previously requested so that speed limits and other highway signs would not be blocked.
3. Signing intersection of Gate 10 Road, Rt. 623 and Belspring Road, Rt. 600 - Ms. Marcelle Jay indicated warning signs for the intersection, as it is approached along Rt. 623, are needed. The need for these warning signs may be reduced, due to the closing of Gate 10 at RAAP.
4. Hazardous low shoulder on the S curve along Rt. 600, Belspring Road, in the vicinity of Gate 10 Road, Rt. 623 - Ms. Jay also called attention to this need. The resident engineer can advise what remedies are possible.
5. Oxford Avenue, Rt. 701, culvert grates - Supervisor Sheffey requested on behalf of a concerned citizen that the grates that may have been removed from the culvert be replaced to prevent children playing in a dangerous area inside the culverts. The resident engineer can advise of the status of the culvert grate replacement.
6. Improvements to one lane bridge at Max Creek on Rt. 693, Julia Simpkins Road - Mr. Steve Cox requested this matter be reviewed. The resident

engineer can confirm whether improvements to Rt. 693 on the six year  
or supplemental plan include this bridge replacement. Mr. Cox also  
requested directional signing to Hoover Color to avoid trucks getting

remedied.

c. Request for Speed Limit Reduction on Rt. 11, Lee Highway, (in the area of Highland Memory Gardens) - See enclosed request from Highland Memory Gardens, Inc.

d. Revised Functional Classification Map Required by Federal Highway Administration  
- See enclosed correspondence requesting a resolution concurring with the classification. Staff will plan to prepare individual maps for distribution prior to the October 26 meeting. If any discretion is allowed for localities, I would suggest that Rt. 100, south of Interstate 81, be classified as a minor arterial rather than the lesser classification of a major collector. I would also suggest that Rt. 627, Highland Road, should be classified as a major collector. Otherwise, the requested resolution is recommended.

SUBJECT: Reports from the County Administrator and Staff

a. Appointments:

NRRA - See enclosed request from the Town of Pulaski that Councilman Crispin be designated the alternate for Town Manager Holycross.

At Risk Youth and Families Community Policy and Management Team - Mr. Wallis is pursuing the creation of a regional team. All New River Valley Planning District Commission cities and counties are interested, with the exception of Montgomery County. A report is expected by the November supervisors meeting.

Local Disabilities Services Board - Use of the American Disabilities Act

Compliance Committee will not satisfy entirely the requirements of the state for a local disabilities services board. A regional board of the New

River Valley Planning District localities is possible. The Planning District staff is pursuing this possibility. A report should be available at the November supervisors meeting.

Office on Youth Advisory Board - A vacancy exists due to the resignation of Ms. Terri Stuart. It is recommended Community Relations Coordinator Terri Gregory be authorized to nominate a successor. A vacancy also exists due to the resignation of Mr. Monroe Gray. Ms. Gregory has nominated Ms. Cheryl Likens to replace Mr. Gray. Ms. Likens served several years ago when she was a student at Radford University and has expressed a desire to be appointed to the advisory board.

Southwest Virginia Development Financing, Inc. - See enclosed request from Congressman Boucher for a county representative with a financing background to oversee this \$1 million tourism revolving loan fund.

b. Cloyd's Mountain Landfill Closure Status and Appreciation of Legislation Support

- See enclosed correspondence from Department of Waste Management Director Woodfin and Senator Marye. Senator Trumbo and Delegate Baker were also helpful in calling this matter to Mr. Woodfin's attention. Also enclosed is a copy of the executed enforcement order. The Board's acceptance of the order as a matter of record is requested, even though authorization was previously given to agree to the order. Two significant portions of the order are authorizing capping with the federal standard clay rather than the plastic membrane required by state regulations. English Construction is presently installing the cap, at a savings of over \$500,000 compared to the plastic membrane. The second major requirement of the order is installation of a sewerline to the landfill with thirty months.

It is recommended that the Board pass a resolution of appreciation to our legislators for their intervention and encouragement of a reasonable closure plan by the Department of Waste Management.

c. School Population Committee Meeting - Confirmation of the meeting time currently being scheduled with the school representatives on the school population

committee, including Supervisors White and Fariss, will be requested.

- c. Transfers and Appropriations - Transfers and appropriations will be presented prior to the October 26 meeting.
- d. Contracts and Change Orders - Any contracts or change orders will be presented prior to the October 26 meeting.
- e. Personnel Changes - See enclosed update from the Director of Management Services.
- f. Old Calfee School Property Transfer - Any report from the T. G. Howard Center regarding interest in release of the county's interest to allow development of a mobile home park by Mr. Michael Boyer adjacent to the center will be shared. To confirm the September action of the Board, it is recommended the transfer be allowed and the county's interest released should the T. G. Howard Center Board of Directors support such release.
- g. VACO Annual Meeting Voting Credentials & Exhibit - It is recommended that Supervisor Vaughan, who represents Region 11 on the Virginia Association of Counties Board of Directors, be designated as the voting delegate for the county

at the 1992 annual meeting. It is recommended the alternate voting delegate be Supervisor Crawford. In addition, it is recommended that Mr. Huber be recognized for his role at the annual meeting in displaying the county's booth which will feature the old courthouse renovation efforts.

h. Christmas Holiday Schedule - In addition to the established holidays, it is recommended the Board grant employees one full day additional leave during the holidays. To accommodate a portion of this additional day, it is recommended offices be closed at noon on Christmas Eve. Thus, the office workers would take one-half of the additional leave on the afternoon of Christmas Eve.

i. Refund of FY 92 Health Department Contribution - A request has been received for refund of FY 92 Health Department local contribution of \$356. It is recommended that the refund be contributed to the Health Department to assist with conversion of the school bus contributed by Floyd County as a mobile clinic. The clinic will be used partially in the county. See enclosed correspondence.

j. Stigger Hill Sewer Service - See enclosed petition for service. Mr. Huber is proceeding to determine the best available source of financing for such service. Authorization to obtain such financing on behalf of the Board of Supervisors is requested.

k. Lucky Winner Facility Private Road - Authorization of a private road off of Route 1030, Bagging Plant Road, is recommended by the County Planning Commission.

l. Recreation Agreement - Enclosed please find the latest version of the agreement. The Town of Pulaski has approved the agreement. The Town of Dublin has the agreement under review and is proposing several clarifications, which are noted on the enclosed agreement. The Board of Supervisors has previously indicated support of the agreement. Authorization to the execute the agreement, along with whatever final adjustments are needed to achieve consensus from the two towns and the county, is requested.

m. Virginia Mountain Housing Request for Tax Exemption on Proposed Fairlawn Apartments for Mentally Ill - See enclosed correspondence from Attorney Harriett Dorsey. To be consistent with past action refusing support of tax exempt status for subsidized housing projects, it is recommended this request also be denied.

Further, it is recommended that Virginia Mountain Housing be informed of the need for a rezoning and site plan review prior to use of the property proposed.

n. Newbern Street Light Agreement Renewal - See enclosed correspondence from Appalachian Power Company. It has been the practice for some twenty or more years for street lights to be available in the Newbern community as a service of the Newbern Community Center. Mr. Henry Farris and Ms. Blanche Rupe are responsible for collection and payment for the street lights. No cost is assumed by the county in providing the street lights. Authorization for the Chairman and Clerk of the Board of Supervisors to execute the agreement renewal for an additional ten years is requested, with appropriate modifications of both the agreement and a resolution authorizing the agreement to reflect the Circuit Court Clerk is no longer the Clerk of the Board of Supervisors.

o. Authorization to Apply for a Rural Economic Development Grant - Authorization is recommended to apply for a Rural Economic Development Grant. The grant will be used for engineering and geotechnical evaluations needed for the development of the airport industrial park and the AT&T site.
