

At a special meeting of the Pulaski County Board of Supervisors held on Monday, May 2, 1994, 7:00 p.m., at the County Administration Building, 143 Third Street, NW, in the Town of Pulaski, Virginia, the following members were present: Jerry D. White, Chairman; Dr. Bruce L. Fariss; Ira S. "Pete" Crawford; and Mason A. Vaughan, Sr. Absent: Joseph L. Sheffey, Vice-Chairman.

1. Call to Order

Chairman White called the meeting to order.

2. Confirmation of Assistance with Volvo GM Heavy Truck Expansion

The Board of Supervisors discussed with staff details of the proposed assistance. The Board then asked the County Attorney, T.J. McCarthy, and Assistant County Administrator, Peter Huber, to review the wording in the proposed letter of intent, particularly involving assistance with road improvements, while the Board went on to the budget work session on the agenda.

Further action on this matter was deferred until following an executive session.

3. Budget Work Session

The Board reviewed several reports prepared by staff regarding the FY 95 budget including a capital outlay listing and a year to date expenditures and revenues report on the Courthouse renovation project. The Board approved changes in the proposed budget as presented by staff.

4. Budget Ad Adoption

On the motion of Mr. Crawford, seconded by Mr. Vaughan and carried, the Board of Supervisors approved the following budget advertisement for FY 95:

Pursuant to the provisions of Title 15.1, Section 162 of the Code of Virginia, as amended, the Pulaski County Board of Supervisors has ordered the publication of the following budgetary synopsis for the fiscal year ending June 30, 1994. It should be noted that the revenue and expenditure estimates contained herein are tentative and are calculated for financial planning purposes. Eventual adoption of the budget outlined below will not necessarily constitute an appropriation of the governing body.

A public hearing will be held on the proposed budget at 7:00 p.m., Monday, May 17, 1993, in the Pulaski County Administration Building, 143 Third Street, N. W. in the Town of Pulaski. Complete copies of the budget are available for public inspection at the Office of the County Administrator, 143 Third Street, N. W. in the Town of Pulaski and the Pulaski County Library. With regard to Mr. Sjoberg's letter of April 11, 1994, requesting clarification of road requirements and in an effort to meet needs as they become known, Pulaski County looks forward to reviewing the traffic count information and to working with VGHT and the Virginia Department of Transportation in utilizing industrial access road funds, CDBG funds, primary road funding and funding from other sources to maximize state assistance with these needs. This information will allow the Pulaski County Board of Supervisors and the VDOT to estimate needed improvements and completion dates.

Upon execution of a counterpart of this letter by you, this letter and the Correspondence, which is hereby incorporated by reference, shall constitute the legally binding and enforceable agreement of the County and VHGT with respect to the Incentives described herein. The parties will negotiate in good faith and use their best efforts to arrive at mutually satisfactory documentation of their agreement regarding the Incentives consistent with the Correspondence.
