

At a regular meeting of the Pulaski County Board of Supervisors held on Monday, July 25, 1994, at 7:00 p.m. at the Pulaski County Administration Building, Board of Supervisors Meeting Room, 143 Third Street, N. W. in the Town of Pulaski, Virginia, the following members were present: Jerry D. White, Chairman; Joseph L. Sheffey, Vice-Chairman; Dr. Bruce L. Fariss; Ira S. "Pete" Crawford; and Mason A. Vaughan, Sr.

1. Invocation

The invocation was given by Reverend Patrick Coffee of Memorial Baptist Church.

2. Additions to Agenda

Additions to the agenda were discussed at the appropriate times on the agenda.

3. Public Hearings

A request by Patricia S. Kanode for an amendment to the zoning map from Residential (R1) to Agricultural (A1) to allow placement of a manufactured home as an additional residence on property identified on Pulaski County tax maps as parcel 54-1-52 located off Route 738, Robinson Tract Road, in the Robinson District

The Chairman opened the public hearing on this matter. No public comments were received; therefore, the Chairman closed the public hearing.

On the motion of Mr. Sheffey, seconded by Dr. Fariss and carried, the Board of Supervisors approved the request.

4. Highway Matters

a. Follow-up from previous Board meetings:

1. Route 672, Lowman's Ferry Road, Speed Study Request

Mr. Thompson reported this request had been submitted to the traffic section for study. The results, however, have not been concluded.

2. Appointment of Road Viewers, Schedule of Road Viewing and List of Potential Roads

The Board of Supervisors agreed to serve as the road viewers and scheduled the road viewing for Saturday, August 13, 1994, to begin at the Bonfire Restaurant at 8:00 a.m.

b. Drainage Problem at End of Route 651, Brown Road

The Board requested VDOT to review a drainage problem at the end of Route 651, Brown Road, below the Water Treatment Plant road.

c. Citizen Complaint re: Paving of Route 601, Little Creek Road

Staff reported a recent citizen complaint regarding paving

of Route 601, Little Creek Road. The Board directed that staff send phone number and name of complainant to the resident engineer for responding.

d. Request for Addition of Kent Farm Road, Route 628, to Six Year Plan for Paving

The Board approved adding this request to the supplementary list to be considered at the next public hearing on the six year road plan update.

e. Other Matters

Supervisor Sheffey inquired of the criteria for asphalt plant mix paving verses tar and gravel surface treatment. Assistant Resident Engineer Thompson advised plant mix is applied usually on secondary roads with over 750 vehicles per day, surface treatment is used with lower traffic counts.

Supervisor Sheffey requested an update at the August 22 meeting on planning for replacing Memorial Bridge and adding an additional bridge across the New River.

Supervisor Crawford requested damage from loose gravel on Barrett Ridge Road be addressed by VDOT.

5. Citizens Comments

Mr. Owen Morgan of Route 625, Morgan Farm Road, presented a petition to the Board of Supervisors requesting speed limit posting and requesting patrolling by the Sheriff's Department.

On the motion of Mr. Sheffey, seconded by Dr. Fariss and carried, the Board of Supervisors requested VDOT to conduct an informal speed study on Route 625, Morgan Farm Road.

Mr. Dan Sumner submitted a request to the Board regarding assistance for beautification at McGhee's Trailer Park. Staff was requested to distribute a copy of this information to each supervisor, as well as copies to be distributed to Code Enforcement Officer, Charles Goins, and County Engineer, Ron Coake.

6. Treasurer's Report

Treasurer Rose Marie Tickle met with the Board and presented the monthly trail balance report. The Board accepted the reports as presented by the Treasurer.

On the motion of Dr. Fariss, seconded by Mr. Sheffey and carried, the Board of Supervisors directed staff to request legislators to seek enabling legislation to allow the county treasurer, and other county government offices, to receive payments by credit card, or other bank cards, at no expense to the county, including through a surcharge to the taxpayer or as a public service from banks. The Board also directed this same request be sent to the VACO legislative committee.

Approval was given of a carryover of \$17,125 for each rescue squad, contingent upon compliance with county procurement policies.

d. Contracts and Change Orders

1. Cloyd's Mountain Landfill - Change Order #5

The Board approved change order number five with W. C. English Construction in the amount of \$12,952.00.

2. Update on Status of Avis Contract and Change Orders, Both Time and Cost

The Board reviewed recent correspondence regarding the over-excavation costs on the brick courthouse construction. The Board requested staff to present any payment or negotiation of costs due to over-excavation to the supervisors for approval with other items to be negotiated at the discretion of the county administrator and reported to the supervisors.

e. Ratification of:

1. VHDA Administrative Services Agreement

The Board approved the Virginia Housing and Development Authority Administrative Services Agreement. A copy of said agreement is filed with the records of this meeting and the Office of the County Administrator.

2. Cleaning Services

The Board approved engaging C & A Cleaning Services for cleaning and custodial services for the County Administration Building and the HUB building for a period nine months for a monthly fee of \$3,465.00.

3. Cost Allocation Plan

The Board approved awarding the cost allocation plan preparation to Robinson, Farmer, Cox Associates for an annual fee of \$2,000.00.

4. Property and General Liability Insurance

The Board approved awarding property and general liability insurance for FY 95 to Old Dominion Insurance Services through Saint Paul Insurance in the amount of \$261,680.00.

5. Victim's Assistance Grant Acceptance

The Board approved an agreement with the Women's Resource Center for the acceptance of a grant from the Department of Criminal Justice Services for the Victim's Assistance program.

f. Credit Card Equipment for Court Clerks

The Board approved a \$560 carryover appropriation for General District Court equipment purchase and approved the use

of county paid phone line for the connection to bank system in order to receive credit card payments for court fees and fines.

g. Cost Allocations on Fiscal and Legal Matters Relating to Comprehensive Services Act

The Board of Supervisors approved the recommendations as presented by Social Services Director Jim Wallis regarding cost allocations on fiscal and legal matters pertaining to the Comprehensive Services Act. Said recommendations are filed with the records of this meeting.

h. Fee on Impoundment for DUI Violations

The Board authorized the county attorney to consult with Sheriff Dobbins and prepare a draft ordinance for review and possible adoption by the Board to allow the Sheriff's Department to collect fees for impoundment of vehicles in general and specifically for violation of Section 46.2-301.1 of the Code of Virginia.

i. Workman's Compensation Claim Physician's Referral

The Board approved utilizing a panel of physicians for non-emergency workman's compensation claims for employees, per the recommendation of staff and worker's compensation insurance carrier.

j. Personnel Changes

The Board reviewed recent personnel changes as presented by Management Services Director Nancy M. Burchett.

k. Relocation of Belspring Polling Place to be included with Justice Department Preclearance of School Board Election

The Board requested County Attorney, Thomas J. McCarthy, Jr., to make the appropriate request for clearance of a new location for the Belspring polling place, along with clearance of School Board elections.

l. Scheduling Public Hearing on Sewage Pretreatment Ordinance for August Supervisors Meeting

The Board scheduled the public hearing on this matter for the August 22, 1994, supervisors meeting.

m. Airport/Cloyd's Mountain Sewer Line Extension

The Board authorized staff to seek twenty year financing on the Airport/Cloyd's Mountain sewer line extension and approved re-routing the line through School Board property currently zoned industrial.

n. Registrar Attendance at State Board of Elections Annual Meeting in Richmond

The Board approved the County Registrar, Phyllis Hanks, attending the State Board of Elections annual meeting in Richmond on August 10, 11, and 12, 1994.

o. Swap of Vehicles with Town of Dublin

The Board approved swapping a wrecked 1988 Blazer owned by the county for a 1989 Chevrolet police cruiser owned by the Town of Dublin. In addition, the Board approved the Town of Dublin assisting the county with snow and ice removal during the upcoming winter.

- p. APCO's Proposed 765 Kilovolt Power Line - Studies by Jefferson National Forest

The Board reviewed correspondence from the Informed Citizens' Act Network requesting endorsement of additional public meetings and an extended study of the line routing. The Board of Supervisors resolved to maintain its current policy of support for the power line and an expedited review without prolonged meetings or additional, duplicative studies.

- q. Town of Pulaski Water Purchase and Sale Agreement

The Board of Supervisors approved the Town of Pulaski Water Purchase and Sale Agreement, with a minor change regarding Route 611, Newbern Road, service area, as recommended by the PSA Board of Directors.

Supervisor Sheffey expressed concern over the rapid filling up of Ingles Mountain Landfill.

Supervisor Sheffey requested the PSA review both a short term and long term solution to water pressure and availability on Hickman Cemetery Road, Route 624.
