

At a regular meeting of the Pulaski County Board of Supervisors held on Monday, June 24, 1996, 7:00 p.m., at the Pulaski County Administration Building, Board Room, 143 Third Street, N.W., in the Town of Pulaski, Virginia, the following members were present: Joseph L. Sheffey, Chairman; Jerry D. White, Vice-Chairman; Dr. Bruce L. Fariss; Charles E. Cook; and Frank R. Conner. Staff members present included County Administrator, Joseph N. Morgan; County Attorney, Thomas J. McCarthy, Jr.; Management Services Director, Nancy M. Burchett; and Executive Secretary Gena T. Hanks.

1. Invocation

The invocation was given by Reverend Stanley Armes of the Pulaski Presbyterian Church in America.

2. Additions to Agenda

Additional agenda items were noted and considered at the appropriate times on the agenda.

3. Public Hearings:

- a. Prohibiting through truck traffic on the following roads in the Newbern Magisterial District: Rt. 611, Wilderness Road, from the intersection of Route 662, Lyons Road, to Route F-047, Possum Hollow Road; Route 683, Charles Drive, from Route 100, Cleburne Boulevard, to Route 1021, Howery Road; and Route 1021, Howery Road, from Route 683, Charles Drive, to Route 682, Newbern Road. The proposed alternate routes available for restricted trucks are as follows: Route 682, Newbern Road, from Route 662, Lyons Road, to Route 100, Cleburne Boulevard; to Route F-047, Possum Hollow Road; to Route 611, Wilderness Road

The Chairman opened the public hearing on the above matter for public comments and requested comments be limited to 5 minutes.

The following individuals spoke regarding this matter:

Mr. Miller T. Farris, Jr., Chief of the Newbern Volunteer Fire Department, appeared before the Board of Supervisors and expressed opposition to prohibiting through truck traffic in this area. Mr. Farris advised milk trucks have to pass through the Newbern community for farms in the area. In addition, Mr. Farris stated trucks also pay taxes in the community and should be allowed to travel on the roads. He further expressed concerns regarding not being able to get a ladder fire truck to the Claytor Lake area and other nearby areas quickly if the truck traffic was prohibited.

Mr. Ken Dobson, a resident of Howery Road, appeared before the Board of Supervisors and advised his street was not designed or constructed for heavy truck traffic. He stated the street was very narrow, dusty, and congested. He requested the Board consider the safety of the children in the area and ask the Board to support prohibiting truck traffic on Charles Drive and Howery Road.

Ms. Phyllis Montgomery, a resident in the Fair Acres Subdivision on Charles Drive, advised she was opposed to the through truck traffic in the area.

Mr. Kevin Hughes, also a resident of Newbern, appeared before the Board and stated he understood the need for through truck traffic for community service, but he was concerned about the use of short cuts in the area should the truck traffic be prohibited. He advised some

middle ground should be reached regarding this matter.

Ms. Edna Mae Pattison of Newbern appeared and advised she was concerned with the safety of the children in the area. She reported no one in the area abides by the present 25 miles per hour speed limit.

Mr. Andy McCready spoke and reported he thought the speeding problem appeared to be as much of an issue as the truck traffic problem. He suggested the Board ask law enforcement personnel to enforce the present 25 miles per hour speed limit and review this

On the motion of Mr. Cook, seconded by Mr. Conner and carried, the Board of Supervisors approved requesting the Virginia Department of Transportation to conduct a study to prohibit through truck traffic on the following road in the Newbern Magisterial District: Route 611, Wilderness Road, from the intersection of Route 662, Lyons Road, to Route F-047, Possum Hollow Road; Route 683, Charles Drive, from Route 100, Cleburne Boulevard, to Route 1021, Howery Road; and Route 1021, Howery Road, from Route 683, Charles Drive, to Route 682, Newbern Road; with the proposed alternative routes available for restricted trucks are as follows: Route 682, Newbern Road, from Route 662, Lyons Road, to Route 100, Cleburne Boulevard; to Route F-047, Possum Hollow Road; to Route 611, Wilderness Road. The Board further resolved to provide enforcement of this truck traffic restriction, should the study determine appropriate, by means of the local Sheriff's Department.

Voting yes: Mr. Cook, Mr. Sheffey, and Mr. Conner.

Voting no: Dr. Fariss and Mr. White.

- b. Amendment to the zoning map being considered by the Pulaski County Planning Commission from Residential (R3) to Residential (R) for property identified on Pulaski County tax records as parcels 029 (1) Lots 1-7A; 029 (1) Lots 23-30; 029 (3) Lots 1-12; and 029 (17) Lots 1-3, located off Route 600, Belspring Road, in the Cloyd District.

County Administrator, Joseph Morgan, reported the Planning Commission recommended denial of this request.

The Chairman opened the public hearing on this matter for public comments. The following individuals spoke regarding this rezoning request:

Mr. Bill Watson appeared and noted he had submitted a petition to the Board of Supervisors requesting the Board not to consider rezoning at this time.

Mr. Jack McCraw advised the residents in the area were opposed to any rezoning.

No further comments were heard; therefore, the Chairman closed the public hearing on this matter.

On the motion of Dr. Fariss, seconded by Mr. White and carried, the Board of Supervisors denied an amendment to the zoning map from Residential (R3) to Residential (R) for property identified on Pulaski County tax records as parcels 029, (1) Lots 23-30; 029 (3) Lots 1-12; and 029 (17) Lots 1-3, located off Route 600, Belspring Road, in the Cloyd District, per the Planning Commission recommendation.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and Mr. Conner.

Voting no: none.

- c. Adoption of an ordinance pursuant to Section 14.1-46.01:1, Code of Virginia, to adjust Board of Supervisors compensation

The Chairman opened the public hearing on this matter for public comments. No public comments were received; therefore, the public hearing was closed by the Chairman.

On the motion of Mr. White, seconded by Mr. Conner and carried, the Board of Supervisors adopted the following establishing the Board

Compensation:

BE IT ORDAINED that the compensation of the members of the Pulaski County Board of Supervisors be set at \$600 per month effective July 1, 1996, which compensation is established pursuant to Section 14.1-46.01:1 of the 1950 Code of Virginia, as amended, and

FURTHER, BE IT ORDAINED, that the compensation for the Chairman of the Pulaski County Board of Supervisors be an additional \$125 per month.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and Mr. Conner.

Voting no: none.

4. Highway Matters:

Virginia Department of Highways (VDOT) Resident Engineer, J.D. Brugh, met with the Board regarding the following.

a. Follow-up from Previous Board meetings:

1. Supplemental List Update

Staff was requested to confirm all requests are listed on the supplemental list for which cost estimates are needed.

2. Request by Mar-Bal for Acceptance of Roads into Highway System

Mr. Brugh, Resident Highway Engineer, advised he need additional information regarding this request. Staff was requested to complete any additional information and submit to VDOT.

b. Little Creek Road, Route 601

Mr. Brugh reported this project could possibly be split up to accelerate the construction and if the Board had no objections he would proceed to split this project for the next six year plan road hearing. The Board voiced no objections to Mr. Brugh's suggestion.

c. Route 114, Pepper's Ferry Blvd. Rural Addition Ineligibility

Mr. Brugh advised this area does not qualify as a rural addition but is only an easement being reserved for utilities. The Board of Supervisors requested VDOT to provide written confirmation on clarification on additional VDOT access for the properties fronting on Route 114 as a steep hill.

d. Route 698, Barsus Road, & Route 627, Highland Road Sight Distance

Mr. Brugh reported this area does have limited sight distance and VDOT could review this with the six year plan update this fall.

e. Route 100, Cleburne Blvd., at Route 627, Highland Road Stop Ahead Alert

Mr. Brugh reported this report had been reviewed with the traffic engineer and he had determined this would not be advantageous due to

low occurrences of individuals running the stop sign; however, he advised VDOT would monitor this area again in the future.

f. Request for Maintenance of Private Road to New River Valley Trailer Park

Mr. Brugh reported this request would be added to the road viewers list for viewing this summer/fall.

g. Pothole Repair on Thaxton Road, Route 649

Mr. Brugh advised this repair had been completed by VDOT.

h. Rt. 809, Collier St. Rural Addition

Mr. Brugh reported this request would also be added to the road viewers list for viewing this summer/fall.

i. Route 736, Irish Mountain Road Paving

Mr. Brugh advised this paving was not in the six year plan; however, it is in the supplemental list and could be considered in the six year plan when the plan is updated this fall. He estimated the cost to be approximately \$167,000.

j. Parkview Subdivision Phase 1D Drainage Easement

On the motion of Mr. White, seconded by Dr. Fariss and carried, the Board of Supervisors approved transferring to the Virginia Department of Transportation the Parkview Subdivision Phase 1D drainage easement.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and Mr. Conner.

Voting no: none.

k. Draper Mountain Wayside Reuse

Discussion was held regarding the ownership of the Draper Mountain Wayside. Mr. Brugh reported VDOT would like to pursue the option of transferring responsibility of the Draper Mountain Wayside to Pulaski County. County Administrator, Joseph Morgan, suggested a lease agreement be drafted between VDOT and the county for the use of the wayside. Staff was requested to draft a lease agreement for the Board to review at the next regular meeting of the Board of Supervisors.

l. Citizen Concerns

Comments were heard from several citizens present in favor of a request to add Route 809 to an extension of Collier Street the road viewers list for possible rural addition.

Mr. Jim Hennon appeared before the Board of Supervisors and requested the status of Route 697, Towes Ferry Road improvements. Mr. Brugh advised this project is being re-advertised with construction expected to begin in September, 1996.

m. Board of Supervisors Concerns

Supervisor Conner requested VDOT repair the potholes in the Mountain View Subdivision.

Supervisor Cook requested VDOT perform a weekend traffic count this summer on Route 658, Delton Road.

Chairman Sheffey requested the status of the Memorial Bridge repairs. Mr. Brugh advised the stabilization has been completed and no weight limit reduction is anticipated. Mr. Brugh further advised additional repairs would need to be done on the Memorial Bridge; however, these would not be done until 1997 or 1998.

5. Site Plan Appeals:

- a. An appeal by Evelyn Alexander, Daniel King, and the Newbern Foundation of the Planning Commission on approval of a site plan for a 28' x 20' addition to the existing Newbern Molding building located on property identified on Pulaski County tax records as parcel 065 (1) Lot 41, zoned Residential (R1), located off Route 611, Wilderness Road, in the Newbern Community of the Draper District.

Mr. Rod Crowgey, Attorney for Evelyn Alexander, appeared before the Board of Supervisors and requested the Board to deny approval of the above matter. Several residents stood also in opposition to the site plan approval.

Mr. Jim Hennon of Newbern Building Company advised he had done all that he had been requested to do in order to obtain site plan approval. Mr. Hennon requested the Board to deny the appeal.

Ms. Jean M. McPeak appeared before the Board and expressed concerns regarding garbage, disposal of the gas tank due to trucks and other traffic posing a hazard with the propane at the site.

On the motion of Mr. Cook, seconded by Mr. Conner and carried, the Board of Supervisors requested the applicant provide to the Board of Supervisors a new site plan outlining in detail all site features, present and proposed, for the Board to review.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and Mr. Conner.

Voting no: none.

- b. Appeal by Supervisor Charles E. Cook of Planning Commission approval of a site plan review requested by Harold Chrisley to allow a flea market on property identified on Pulaski County tax records as parcel 056 (1) Lot 73, zoned Commercial (CM1), located on Route 100, Cleburne Boulevard, near the Town of Dublin in the Draper District

Mr. Harold Chrisley, owner of the above property, appeared before the Board of Supervisors and outlined the history of the above property and its recent use as a flea market.

Mr. Clarence Chrisley spoke to the Board of Supervisors regarding this property being used as a flea market. He advised there had been no problems regarding trash and provided information pertaining to number of spaces, fee for space, restroom facilities, and flea market schedule.

Mr. Patsy Akers, Chairperson for the Dublin Planning Commission, appeared and expressed concerns regarding the appearance and safety of the area due to the flea market activities.

Mrs. Edna Mae Pattison appeared before the Board and expressed

support for the flea market in this area.

Mr. E. W. Harless commented he did not think the flea market activity created any problems in the area at this time.

Supervisor Cook expressed concerns regarding the flea market in this area of the county. He advised with the Board of Supervisors trying to clean up the county, this activity did not improve the image of the county.

The Board of Supervisors took no action at this time on this matter.

6. Treasurer's Report

The Board of Supervisors reviewed the monthly trial balance report and certificates of deposits, as presented by the Treasurer, Rose Marie Tickle. The Board accepted the reports as presented.

7. Citizens Courthouses Exhibits Committee

Dr. David Poteet appeared before the Board of Supervisors on behalf of the Courthouses Exhibits Committee to request the Board reconsider holding the Courthouse Centennial activities on October 5, 1996. Dr. Poteet outlined proposed activities for this event.

On the motion of Mr. White, seconded by Mr. Cook and carried, the Board of Supervisors approved designating October 5, 1996 as the date to celebrate the 100th birthday of the Pulaski County Old Courthouse along with necessary funding for a banner and refreshments to include a cake for this event.

Voting yes: Mr. Cook, Mr. Sheffey, Mr. White, and Mr. Conner.

Voting no: none.

8. Introduction of New NRV Economic Development Alliance Executive Director

Joseph Morgan, County Administrator, introduced to the Board of Supervisors Mr. Stuart Gilbert, the new NRV Economic Development Alliance Executive Director. Mr. Gilbert advised the Board of a strategic planning session planned for July 30 and invited Board members to attend this if possible.

9. Citizen Comments

Mr. Don Rainey appeared before the Board and presented correspondence regarding a conflict of interest determination in his role as a member of the County Planning Commission.

10. Reports from the County Administrator & Staff:

- a. A Request by Pulaski County Developers (L C) for a Conditional Use Permit to allow quarrying operations on property identified on Pulaski County tax records as parcels 057-001-0000-0002, 002B, 002D, 0003 and 066-001-0000-0002, zoned Agricultural (A1), located off Route 611, Wilderness Road, in the Ingles District

On the motion of Dr. Fariss, seconded by Mr. White and carried, the Board of Supervisors tabled action on this matter until the August Board meeting to allow confirmation of areas of agreement or disagreement between the parties involved in this issue.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and
Mr. Conner.

Voting no: none.

b. County Entrance Signs Status

The Board of Supervisors reviewed cost estimates for county entrance signs as provided by staff. The signs included an alternative that would display the county seal. The County Administrator advised these signs could be erected on Interstate 81 with the proper permits from VDOT.

On the motion of Dr. Fariss, seconded by Mr. White and carried, the Board of Supervisors authorized staff to pursue the necessary permits from VDOT to erect a 6 foot x 16 foot entrance sign, without the county seal, at two locations off Interstate 81.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and
Mr. Conner.

Voting no: none.

c. Draft Dog Control Ordinance Review

The Board reviewed a draft dog control ordinance, as prepared by County Attorney, Thomas J. McCarthy, Jr. The Board discussed the cruelty to other animals section of the draft ordinance and dates for the purchase of dog tags.

On the motion of Frank Conner, seconded by Mr. Cook and carried, the Board of Supervisors authorized staff to advertise the draft ordinance for public hearing at the July supervisors meeting.

Voting yes: Mr. Cook, Mr. Sheffey, Mr. White, and Mr. Conner.

Voting no: Dr. Fariss.

Dr. Fariss requested the County Attorney to contact other counties to determine how other counties handle animal cruelty.

d. Designation of Official County Colors and Flag

On the motion of Dr. Fariss, seconded by Mr. White and carried, the Board of Supervisors requested the Courthouses Exhibits Committee to make a recommendation to the Board of Supervisors regarding county colors and a county flag by January 1, 1997. Said recommendation to include input from citizens.

Voting yes: Dr. Fariss, Mr. Cook, Mr. Sheffey, Mr. White, and
Mr. Conner.

Voting no: none.

e. Randolph Park Plan Display

On the motion of Dr. Fariss, seconded by Mr. Conner and carried, the Board of Supervisors instructed staff to prepare posters (color and laminate) of the Randolph Park for display in public areas such as libraries, courthouses, banks, town halls, etc., this summer and in the schools this fall to recruit citizen volunteers.
