

At a regular meeting of the Pulaski County Board of Supervisors held on Monday, October 28, 1996 at 7:00 p.m. at the County Administration Building, Board Room, 143 Third Street, N.W., in the Town of Pulaski, Virginia, the following members were present: Joseph L. Sheffey, Chairman; Jerry D. White, Vice-Chairman; Dr. Bruce L. Fariss; Charles E. Cook; and Frank R. Conner. Staff members present included County Administrator, Joseph N. Morgan; County Attorney, Thomas J. McCarthy, Jr.; Management Services Director, Nancy M. Burchett; and Executive Secretary, Gena T. Hanks.

1. Invocation

The invocation was given by Reverend Terri Sternberg of the Trinity Lutheran Church.

2. Additions to Agenda

Additional agenda items were noted and considered at the appropriate times on the agenda.

3. Public Hearing - A request by Deborah Long for an amendment to the zoning map from Residential (R3) to Conditional Industrial (I1) to allow a Daycare center on property identified on Pulaski County tax maps as parcel 039-001-0000-0064, located on Route 604, Annie Akers Rd., southeast of Route 621, Brooklyn Rd., in the Fairlawn area of the Cloyd District or a text amendment to allow daycare centers in residential zones by right of Special Use Permit or Conditional Use Permit.

County Administrator, Joseph N. Morgan, advised the Planning Commission had recommended denial of the rezoning request; however, the Planning Commission recommended the zoning text be amended to allow day care facilities by Conditional Use Permit and further recommended approval of the ABC Playschool with certain requirements.

The Chairman opened the public hearing on this matter. The following individuals addressed the Board of Supervisors:

Ms. Deborah Long, spoke in favor of her request. The following citizens spoke in opposition or asked questions about the request: Edgar Akers and Mike Huff.

No further comments were heard, therefore, the Chairman closed the public hearing on this matter.

On the motion of Dr. Fariss, seconded by Mr. White and carried, the Board of Supervisors denied the rezoning request on above described property.

On the motion of Dr. Fariss, seconded by Mr. White and carried, the Board of Supervisors approved amending the zoning ordinance text to allow

day care centers in Residential (R3) zones with a Conditional Use Permit.

On the motion of Dr. Fariss, seconded by Mr. Cook and carried, the Board of Supervisors approved a Conditional Use Permit for Ms. Long and the ABC Playschool subject to the following conditions: 1) installation of a six (6) foot privacy fence within thirty (30) days of opening, 2) review of the Conditional Use Permit by public hearing in eighteen (18) months and thirty-six (36) months, and 3) hours of operation be limited to 5:30 a.m. through 6:30 p.m.

#### 4. Highway Matters:

Virginia Department of Transportation (VDOT) Resident Engineer, Dan Brugh, met with the Board regarding the following:

##### a. Follow-up from Previous Board Meetings:

##### 1. Supplemental List Update

The Board requested VDOT prepare the supplemental listing in the order citizens have made requests, and send a draft plan prior to the November Board meeting for the Board to review. Further, VDOT was requested to advertise the public hearing on the Six Year Plan for the November meeting of the Board of Supervisors.

##### 2. Route 807, Hatcher Road, Traffic Count

The Board reviewed a correspondence from VDOT regarding the traffic count for Route 807, Hatcher Road.

##### 3. Route 600, Parrott River Road

The resident engineer reported the estimated cost of improvements to Route 600, Parrott River Road, to be approximately \$100,000. The Board requested this project be added to the supplemental listing.

##### 4. Draper Mountain Wayside Plan of Operation and Maintenance Cost

The Board reviewed a report from the County Administrator regarding the Draper Mountain Wayside plan of operation and maintenance costs. The Board requested staff provide a report detailing Phase I & II of the plan and scope of the ISTE grant for the future supervisors meeting.

5. Traffic Count on Route 611, Wilderness Road, from Route 660, State Park Road, to Route 682, Newbern Road

The Board reviewed a classification counts report performed by VDOT on Route 611, Wilderness Road, from Route 660, State Park Road, to Route 682, Newbern Road. Said report revealed 30% of total traffic was truck traffic.

The Board reconfirmed an interest in exploring industrial access or other planning assistance available for an alternate industrial traffic quality road for this area. Staff was requested to work with VDOT in exploring alternatives available.

- b. Speed Limit Request on Route 806, Ebb Hall Road

The Board requested VDOT to perform an informal speed study on Route 806, Ebb Hall Road, and advise of results at the November meeting of the Board.

- c. Route 99 Widening Project

On the motion of Mr. White, seconded by Mr. Conner and carried, the Board of Supervisors adopted the following resolution supporting the widening of Route 99, Count Pulaski Boulevard:

WHEREAS, the Town of Pulaski, Virginia, has requested the Virginia Transportation Board to review and approve a one half (1/2) mile section of Route 99 for widening in conjunction with the Town's Urban project planned for Route 99; and

WHEREAS, Route 99 is the Town of Pulaski's only direct connection to Interstate 81, as well as, primary access for the southern portion of the County to the Town, County and Court offices; and

WHEREAS, approval of this project in conjunction with the Town's urban project would result in savings to the State from the design, bidding and construction phases;

NOW, THEREFORE, BE IT RESOLVED, the Pulaski County Board of Supervisors supports the Town of Pulaski's request for the four laning of Route 99 and requests the Virginia Department of Highways & Transportation Board to approve said project.

- d. Request to Add Newbern Avenue (Fair Acres Street) to Rural Additions (located in FairAcres Subdivision)

A resident of Newbern Avenue appeared before the Board and requested that Newbern Avenue, now known as Fair Acres Street, to added as a rural addition to the secondary system.

On the motion of Dr. Fariss, seconded by Mr. Cook and carried, the Board of Supervisors approved adding Fair Acres Street to the listing of rural additions to the viewed by the Road Viewers.

- e. Request to Town of Pulaski for Patrolling Assistance - (Area Off Robinson Tract Road behind Gator Mart)

The Board of Supervisors requested VDOT to review this area for possibly restricting loitering areas.

- f. Scheduling of Road Viewing

The Board of Supervisors scheduled the road viewing for Saturday, November 16, 1996 at 8:00 a.m. with supervisors to meet at the County Administration Building.

- g. Supervisors Concerns

Supervisor White requested temporary paving of Route 636, Alum Spring Road, near Route 648, Snyder Lane, where utility work was recently performed.

Supervisor White reported signs leaning throughout the county. Mr. Brugh advised the signs would be straightened as time and personnel are available.

Supervisor Conner advised that Route 611, Wilderness Road, and Old Route 100, Cleburne Boulevard still needs turning arrows.

Supervisor Cook requested the status of improvements to Route 652, Barrett Ridge Road, and Route 697, Towes Ferry Road. Mr. Brugh advised the pre-construction conference had be-/to advised t2rugh t 0 . 0 4 T s 0 .

repairs. Mr. Brugh confirmed the structure will be replaced in the same vicinity as old bridge, but not before mid 1999.

h. Citizens Concerns

No citizen comments were heard at this time.

5. Treasurer's Report

The Board of Supervisors reviewed the monthly trial balance report and certificates of deposits, as presented by Treasurer, Rose Marie Tickle. The Board accepted the reports as presented.

Treasurer Tickle also requested the Board of Supervisors to approve a disposal request for paid personal property tax tickets for 1987, 1988, 1989, and 1990; and for paid real estate tax tickets for 1987, 1988, 1989, and 1990, 1st and 2nd half all years.

On the motion of Mr. White, seconded by Mr. Conner and carried, the Board of Supervisors approved the disposal request of the above paid tax tickets as requested by Ms. Tickle.

- e. Board of Supervisors Photograph

At this time the Board of Supervisors had their photograph taken for a holiday greeting photo.

- g. Sheriff's Offices Renovation

The Board of Supervisors acknowledged receipt of a letter from Sheriff Ralph Dobbins commending the County's General Properties staff for the recent renovation work at the Sheriff's Office. Said letter commended staff for an exceptional job and expressed appreciation to all those employees who were involved in the renovation of the Sheriff's Office.

h. Constitutional Amendment #1

On the motion of Mr. White, seconded by Mr. Conner and carried, the Board of Supervisors adopted the following resolution of support for the passage of Constitutional Amendment #1:

WHEREAS, the Virginia Association of Counties has joined with the Virginia Education Association, the Virginia Municipal League, the Virginia Governmental Employees Association and six other organizations to form a coalition supporting the passage of Constitutional Amendment Question #1 on the November 5, 1996 ballot; and

WHEREAS, passage of this amendment will change Virginia's constitution to require the Commonwealth of Virginia to hold Virginia Retirement System funds separately from other state revenues and will prevent the funds from being appropriated for any other purpose;

NOW, THEREFORE, BE IT RESOLVED that the Pulaski County Board of Supervisors hereby supports passage of Constitutional Amendment #1 to ensure that VRS trust funds will be safeguarded and not appropriated for any other purpose than paying benefits to members and beneficiaries of the Virginia Retirement System.

c. Domestic Violence Prevention Officer Grant

The Board ratified a grant application to the Department of Criminal Justice for the employment of a Domestic Violence Prevention Officer for the Sheriff's Department.

e. Personnel Changes

The Board reviewed recent personnel changes as presented by Management Services Director, Nancy M. Burchett.

f. Commerce Park Report

Staff reported work on a concept map for the grouping of major potential industrial development property in the vicinity of Dublin, Newbern, Pulaski and the New River Valley Airport. Staff advised as soon as the map of the concept area was completed the information would be shared with the Board members.

g. Public Assembly Ordinance

Staff advised the Sheriff is presently obtaining a copy from Montgomery County an ordinance to use as an example to respond to the large public assembly experience in Fairlawn last weekend. An update on this matter to be made at the November meeting of the Board.

9. Citizen Comments

Citizen comments were heard from Mr. Dale Hoffman and Mrs. Faye Hoffman expressing opposition to the location of the regional jail, as well as opposition to the regional jail concept.

10. Other Matters from Supervisors

Supervisor Fariss inquired about the new public address system for the Board Room. Staff advised vendors had been contacted regarding a new system.

Supervisor Fariss expressed concerns regarding the Cable TV system in Pulaski County. Supervisor Fariss made a motion for the Board to create a Cable TV Citizens Advisory Committee to review cable TV services in Pulaski

County and requested staff contact Mr. Carl Epley and Tom Wilkenson to consider servicing on the advisory committee. Motion was seconded by Mr. Conner and carried.

Supervisor Fariss advised of concerns pertaining to the Virginia Department of Health fee for a mobile home placement within the County. Supervisor Sheffey advised of a resident of Highland Park, Mr. Saul, who advised his property needed re-seeding due to the sewer line installation in Highland Park. Staff was requested to respond to this request.

The Board also requested staff to research the past jail study and obtain costs of a new or expanded regional jail for inclusion in the weekly update to the Supervisors.
