SUBJECT: Public Hearings

SUBJECT: Highway Matters

- a. Follow-up from Previous Board meetings:
  1. Memorial Bridge Status – An update can be provided by the resident engineer.
  2. STAA STATUS – Mr. Andy McCready inquired of the status at the October meeting. The Board of Supervisors had previously requested STAA status for Route 611, Newbern Road, Route 694, Wurno Road, and all roads serving industrial parks.
  3. New River Industrial Park Road Acceptance – Acceptance of the road as a rural addition, as recommended by the road viewing that was done on October 27 is requested, along with all necessary documentation to satisfy the requirements of VDOT.
- b. Six Year Plan Adoption – Adoption of the proposed plan is recommended. ***Enclosed*** is a listing of items in the proposed plan as presented at the October public hearing.
- c. Six Year Plan Waiting List Update – ***Enclosed*** is a listing of those items previously placed on the waiting list. All the items have not been prioritized.
- d. Rt. 11, Lee Highway, Speed Limit Request – The Board was advised at the October meeting of Mr. Joseph Robbins concerns. Mr. Robbins has indicated an interest in making a presentation to the Board. He has been advised the entire area is under review, in case he wants to wait for Planning Commission review prior to making his presentation. At its November meeting, the commission scheduled hearings in December to consider rezoning the northern side of Route 11 in this area to commercial (CM-1). The commission also recommended the intersection of Route 643, Thornspring Road, with Route 11, Lee Highway, be relocated west of Cougar Express convenience store and realigned for a perpendicular intersection with improved sight distance.

- e. Speed Study Request, Rt. 663, Owens Road – Ms. Connie Lee of Cabin Land Drive has requested an informal speed study. I believe VDOT has already reviewed this area, particularly in the vicinity of the Claytor Lake estates and adjacent residential subdivisions.
- f. Rt. 611, Bob White Blvd., Traffic Concerns - ***Enclosed*** is correspondence from Robert A. Hudson, Jr. expressing concerns regarding the traffic on this road. I advised Mr. Hudson improvements to the road are on the waiting list for the six year plan. I also advised that conversion of the road to primary road status was unlikely and would not guarantee better access to funding. I further advised of the long standing request from the Board of Supervisors to the legislature to increase road funding, with a gas tax increase if necessary.
- g. Rt. 738 Robinson Tract Road Tractor/Trailer Prohibition - Ms. Chris Setzler has expressed concern over tractor trailer traffic using Route 738 to reach I-77 via Bland. She requests signage discouraging such traffic and questions whether improvements to Route 738 over Robinson Tract are appropriate if they will encourage more heavy traffic.
- h. Road Viewing - Board members are reminded that the viewing was scheduled for Saturday, December 6 at 8:00 a.m., beginning at the County Administration Building. A tour of the New River Industrial Park is also planned.
- i. PCHS School Zone Signs – Supervisor Cook has inquired whether the sign noting the end of the school zone leaving the intersection of Route 643, Cougar Trail Road, with Route 11, Lee Highway, needs to be removed, since the new traffic signal has been installed at this intersection.
