

BOARD OF SUPERVISORS MEETING MINUTES OF JULY 4, 2012

At a special meeting of the Pulaski County Board of Supervisors held on Wednesday, July 4, 2012 at 9:30 a.m. at the Dublin Middle School in the Town of Dublin, Virginia, the following members were present: Joseph Sheffey, Chairman; Charles Bopp, Vice-Chairman; Andy McCready; Ranny O'Dell; and Dean Pratt. Also present was Peter Huber, County Administrator; and Mike Williams, Patriot Newspaper.

1. Welcome and Introduction

Mr. Sheffey called the meeting to order and advised the purpose of the meeting was to receive a report on the recent storm damage and subsequent response by county staff and others, as well as to adopt a resolution declaring a local emergency.

2. Declaration of Local Emergency

On a motion by Mr. Pratt, seconded by Mr. Bopp and carried, the Board adopted the following Declaration of Local Emergency, Pulaski County, VA:

**WHEREAS**, the Director of Emergency Management of Pulaski County did hereby find:

1. That due to severe weather conditions including high winds Pulaski County faced dangerous conditions;
2. That due to the high wind in combination with the widespread loss of power and threat of extreme heat a condition of extreme peril to life and property necessitated the proclamation of the existence of a local emergency;

**NOW, THEREFORE, IT IS HEREBY PROCLAIMED** that an emergency does exist throughout the County of Pulaski, VA; and

**IT IS FURTHER PROCLAIMED AND ORDERED** that during the existence of said emergency, the powers, functions, and duties of the Emergency Management Organization of Pulaski County were those prescribed by State Law and the Ordinances, Resolutions, and approved plans of Pulaski County in order to mitigate the effects of said emergency.
