Sealed bids are invited for the Roof Repair Project for Central Gym and County Administration Building in Pulaski, Virginia. This project includes 26,500 SF of roofing work. The roofing includes new 90-Mil EPDM, Architectural Shingles and one section of roof coating. Included is masonry repairs and pre-cast band replacement.

Sealed bids will be received at the office of **Ronnie Nichols, Director of Operations, Pulaski County, 143 Third Street N.W., Suite 1, Pulaski, Virginia 24301.** The deadline for submitting bids is **2:00 P.M. sharp**, as determined by the Bid Officer on **December 20, 2019.** The bids will then be opened publicly and read aloud.

A Bid Bond and Contract Security will be required of all bidders regardless of amount.

Procedures for submitting a bid, claiming an error, withdrawing of bids and other pertinent information are contained in the Instructions to Bidders, which is part of the Invitation for Bids. Withdrawal due to error in bid shall be permitted in accord with Section 9 of the Instructions to Bidders and §2.2-4330, Code of Virginia. The Owner reserves the right to reject any and all bids.
