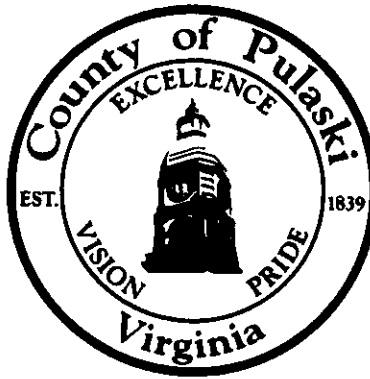

The Board received Kathryn Webb's letter stating her desire to be reappointed Registrar this year.

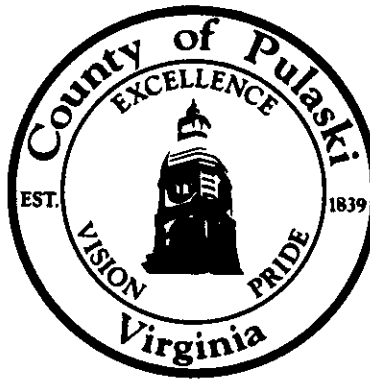
The next meeting will be held on March 18, 2019 at 8:30 a.m. for the purpose of reorganization of the Board.

The list of Election Officials for 2019 was discussed.

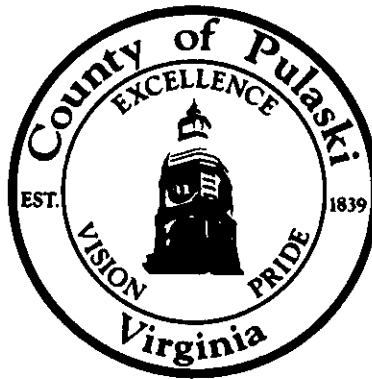
The date of June 11, 2019, 8:30 a.m., was set for the Registrar's Annual Review as well as Reappointment. (Primary Date)
