

Pulaski County Childcare Centers Emergency Recovery Grant Program

Our Childcare Centers and the services they provide are essential to Pulaski County, our business community and our workforce and we are here to assist you with navigating these difficult times. The Pulaski County Board of Supervisors has made available funds to support our Childcare Centers and help with your recovery and response to COVID-19 efforts.

Financial assistance for Childcare Centers in Pulaski County impacted by COVID-19 will be made available on August 3, 2020. Pulaski County Childcare Centers Emergency Recovery Grants in the amount of up to
 \$10,000.00 grants can be used for <u>critical</u> operating expenses to offset some of the impacts of the shutdown and aid in responding to COVID-19. Critical expenses include but are not limited to payroll, operating and reopening expenses.

Eligibility

- Both for-profit and non-profit certified Childcare Centers that are based in Pulaski County, Virginia
- Pulaski County Childcare Centers that were in operation prior to February 15, 2020
- Pulaski County Childcare Centers that are registered and in good standing with the State Corporation Commission (SCC) annual fees (as applicable)
- Pulaski County Childcare Centers that have all required state licensures and certifications as of July 15, 2020
- Pulaski County Childcare Centers that are up to date on all Pulaski County taxes, charges and fees

How to Apply

The County of Pulaski will administer the program. Forms can be downloaded from the Pulaski County website at: <u>www.pulaskicounty.org</u>. Applications will be accepted on a first come first served basis starting on August 3, 2020.

<u>NOTE</u>: The entirety of the Pulaski County Childcare Centers Emergency Recovery Grant Program is funded at a level of \$30,000.00 through a CARES Act appropriation to Pulaski County, Virginia. The program will conclude on December 1, 2020, <u>or</u> at which time the funds for the program have been depleted.
