### Business Entity Filing: Reserve or Renew a Business Name

Trade names must be recorded with the Virginia State Corporation Commission (SCC). The SCC is a state agency with regulatory authority over many business and economic interests in Virginia. A one-time fee of \$10.00 is required upon filing. Form SCC631-Application for Reservation or Renewal of Reservation of a Business Entity Name must be completed. File online or by paper:

#### Register a Corporation or Limited Partnership

Corporations and Limited Partnership businesses must register with the Virginia State Corporation Commission. To become incorporated in Virginia, a business must file trade names, DBA's articles of incorporation and amendments with the State Corporation Commission. ### State Contractors License

Contractors are required to obtain a Business License from the County of Pulaski. Contractors must provide their State Contractor License number. Also, the Contractor's Certificate of Workers Compensation Insurance form (61-A) must be completed and can be found on our webpage. License fee is based on contract amount. If gross contract is less than \$100,000, a minimum license fee of \$30.00 will apply. If contractor does not have a State Contractors License a Contractor Affidavit must be completed. Affidavit states contractor will not perform any work value at \$1,000 or more per project or the total value of all projects in a twelve-month period does not equal or exceed \$150,000 nor will any landscape irrigation or water well work be performed.
