### Pulaski County's Experiential Center

Pulaski County announces the Experiential Center project that will creatively and strategically showcase the County's assets and resources.

Due to COVID-19's economic impact, the project aims to recognize and elevate Pulaski County's untouched economic potential and Pulaski County's assets, including education, industry, housing, health systems, lifestyle and outdoor recreation.

"It is essential that we differentiate ourselves from other communities that compete in our market for available talent and investments," said Jonathan Sweet, Pulaski County Administrator. "It is now more important than ever that we enhance our assets and innovation marketing sales methods to be a winner in this highly competitive post-COVID environment."

Pulaski County's Experiential Center will serve as a one-stop-shop resource and sales center for residents, developers, investors, employers and visitors. The Center aims to celebrate and serve the Pulaski County community by celebrating all aspects of the Pulaski County Community as well as the County's future.

"The number one commodity of the 21st Century is people, and people are what is going to make our economy strong, our community sustainable and our future prosperous," Sweet said. "Thus, we need to utilize every strategic approach to showcase all the exceptional elements of the County and grow to a healthy and favorable population of 40,000 by the year 2030."

The Experiential Center will be located at Pulaski County's current Visitor Center located in Dublin off of exit 98 on I-81. "Our building is beautiful and enriched with Pulaski County pride, but it is underused," said Peggy White, Pulaski County Tourism Director.

Pulaski County built the Visitor Center in 2002 and saw its peak in 2009 with 12,000 visitors. By 2018, the number of visitors declined to 6,000 with the influx of technological advancement and online resources. With COVID-19 and online reservation systems, the number of visitors to the center has declined to 495 visitors per year.

"What some see as the end of an era, we see as the beginning of an opportunity," White said.

Visitor Centers across the commonwealth are shutting down or reinventing themselves due to lack of utilization and online trends. Various visitor centers across the New River Valley have shut down in recent years.

As the concept for the Experiential Center developed, Pulaski County leadership had an opportunity to experience firsthand a sales center concept at the VDEP's Talent Accelerator in Richmond. From that encounter the excitement grew when they realized what a synergistic approach could do to promote and serve Pulaski County.

"The Experiential Center will position Pulaski County with the unique ability to showcase all the assets we have to offer under one roof," said Bill Cunningham, Pulaski County Chamber of Commerce President and Pulaski County Economic Development Authority Board Member. "This concept, along with all the other forward thinking projects we have in our County, will provide us the opportunity to become a next-level rural community."

The transformation aligns with Pulaski County's strategic plan and future housing and lifestyle developments.

The Experiential Center project and transformation will begin in Spring 2022.

#### The Time is Now

The one important component other than 'location, location', that most people agree is critical to the success of siting an important project is - 'Timing is everything'. I could not agree more, quite frankly, with both of these elements of success. With Pulaski County quickly evolving into a Next-Level Rural Community, many would believe the timing for many strategic initiatives are now. One specific project that has eluded Pulaski County for a very long time that became even more apparent as a result of the residual effects of COVID-19 is a community center for all our citizens to access and enjoy. With the shutout of our public school facilities to host sports and recreation activities within their gyms and other formerly accessible spaces, it further elevates the need and paradoxically the demand for such community facilities. The County recently undertook a complete restoration and upgrade of Central Gym using CARES funding and labor provided by our Parks & Recreation and General Properties Departments. The end product resulted in a beautifully restored gym that is now the most used indoor public sports facility in the County. Unlike many localities during the pandemic, Pulaski County worked creatively and resourcefully to safely continue to provide important recreational programming to our youth. We had to run the entirety of our Parks & Recreation youth and adult programs out of only two County gymnasiums - Central and Old Riverlawn. Although this was a difficult and daunting feat of logistical brilliance, it significantly limits the County and our citizens with what programming we can offer. Because of what we are now learning to be the post-COVID mental health impacts from closures, social distancing, loss of access to healthy outlets, and all of the other negative residual fallout, it has never been more important for communities to focus on what healthy programs and activities we can provide to our citizens. I know what you are thinking because I have done my homework on the subject matter, and know that the County pursued the dream of a recreation facility in the not so distant past. That effort was met with fierce objection by a few and the project never had the opportunity to advance. That was over 10 years ago, and now here we are. Perhaps having had that level of capacity along with the dedicated and creative Parks & Recreation Team we have today, would have allowed us to have continued on with programs, activities and initiatives for our youth and our young and seasoned adults during and after the pandemic. Unfortunately, we will never know. I appreciate that there are a lot of questions to answer before we can embark on such an important and noble cause, such as: "what exactly? where exactly? and, how much exactly." As the County looks to keep our most important asset here (our children), attract new talent to our community and create an environment that will host new economic opportunity, it may be the appropriate time to answer those important three questions. At this juncture I do not know what exactly we would build, where exactly it would go, or exactly how much it would be, but one thing I do know considering the critical need for indoor recreational space and the importance of youth and adult sports and programs are to our physical and mental health - the time is now.

# COURTHOUSE WAR EXHIBIT NEARING COMPLETION JULY 4, 2022 DEDICATION DATE PLANNED FOR EXHIBIT

Work on Pulaski County's war exhibit is near completion. Located on the 3<sup>rd</sup> floor of the Old Pulaski County Historic Courthouse, the exhibit is entitled, "Remembering the Sacrifices for Freedom", and is dedicated to the local men and women who have served in our armed forces. Historic war items from all major wars and conflicts, beginning with the Revolutionary War and ending with the Afghanistan War, will be on display. The exhibit includes a "Collage of Soldiers" wall with local soldiers' photos, two war dioramas for World War II and the Vietnam War, military uniforms, pictures, medals, written war narratives / timelines, a military library with books, tapes, and other materials pertaining to war subjects, and many more unique items that have been either donated or loaned to the county by citizens.

This exhibit has been a project of the Pulaski County Courthouses Exhibits Committee for several years. Committee members are very excited to share this exhibit with county citizens and others. Therefore, an open house and dedication ceremony for the exhibit is being planned for July 4, 2022. The exact time and other program details have not yet been determined, but will be on the county's website and in the local newspapers as soon as the details are finalized. So, please make plans to attend this very special event on July  $4^{th}$  as we honor and pay tribute to our local soldiers.
