# Pulaski County Announces New Online Permitting System

Pulaski County Administration is pleased to announce that a new online permitting system is now available to the public. The Energov Citizen Self Service Portal offers a "one stop shop" to apply for, track, and manage both permits and plans. The online portal provides easy access for users to schedule inspections, make payments and print permits and plan approval from the users account.

The Energov platform is supported by Tyler Technology. This cloud based solution is currently used by hundreds of municipalities across the United States across a variety of products. Twenty-two (22) of the twenty-five (25) largest counties in the United States are currently using Tyler products.

The Community Development Office, which includes Engineering, Building and Planning/Zoning participated in a year-long collaboration with the Information Technology Department and Tyler Technologies to develop and customize the new permitting and plan review platform. Paper applications and processes have been converted to the online format. The overall vision for the online platform is to eliminate the use of paper and inefficient processes to save both time and money for the county and its citizens.

"This new platform is just another example of Pulaski County's effort to provide the highest level of customer service, keep up with industry standards and expedite the development demands we are experiencing in the County", stated Jonathan D. Sweet, County Administrator. "Our Community Development Office is staffed with top-tier professionals and feel this new tool will increase capacity and accessibility that will prove to give our citizens and customers an even better end-product and option of experience."

The Citizen Self Service (CSS) platform is available from the Pulaski County website at the Home page (<a href="http://www.pulaskicounty.org/">http://www.pulaskicounty.org/</a>) and the webpages for the Building Department, Planning Department and Engineering Department. Users are required to register with an active email the first time they log in. Once a user is registered in the system, the permitting process is user friendly and convenient to access. The portal organizes the permits and plans associated with a user, which allows the user to track past or current permits. The new system allows building inspection staff to log inspection reports in real time. This feature allows users to track projects without having to contact the office. Payments can be made online using a credit card and the system automatically sends invoices, receipts and permits to the email on file. Citizens who lack the technology to use the online service can still apply for permits by contacting the Community Development Department. Staff is available to assist users of the new system and answer any questions about the new permitting system. Contact Pulaski County Community Development Office 540-980-7710 for assistance.

## FINE ARTS CENTER NEWS

Holland, the Director of the Studio School at the Virginia Museum of Fine Arts. The Fine Arts Center is coordinating this year's biennial with co-sponsors, the Blacksburg Regional Art Association and the Floyd Center for the Arts. All are welcome to the show and reception.

Our adult and children classes are in full swing. October features Taylor Carroll, who will be showing you how to **Illustrate and Animate your Pet on an iPad** using low-cost software. Greeting cards will be the focus of our November classes with a workshop on November 4, 2021, in which you can make and take four greeting cards and a calligraphy workshop on November 13, 2021. ## When to Call 9-1-1

A call to 9-1-1 should always be a call for Emergency Help

#### When should I call 9-1-1?

Life and death emergencies and in-progress crimes against property which include, but are not limited to:

- Life threatening situation

- Hazardous Chemical spills

- Smoke detector, carbon monoxide alarm or other alarms sounding
- Fires
- Smoke in a building
- Motor Vehicle Crashes
- If you see someone hurting someone else
- Injuries requiring medical attention
- To get help for someone who is hurtIf you see someone taking something that belongs to someone else or breaking into a home

or business

#### When not to call 9-1-1.:

Calling 9-1-1 as a joke or knowing that an emergency situation does not exist is a crime and subject to prosecution. If you call 9-1-1 to see if it is working, stay on the line and advise the operator you are just testing.

Non-emergency situations, including:

- For information such as "What are the road conditions?" "When is the parade?" "Why is the power off and when will it be back on?"
- For directory assistance we have to look up the number just as you would
- Abandoned vehicles
- Asking for directions
- Parking complaints
- Questions about tickets, warrants, court dates
- Someone setting off fireworks

#### What if I need Law Enforcement or Fire assistance, but it's not an emergency?

The non-emergency number for Law Enforcement, Fire Departments, Emergency Medical Services in Pulaski County is 540-980-7800. This number is answered 7 days a week, 24 hours a day.

#### What if I call 9-1-1 by mistake?

**DO NOT HANG UP!** If you call 9-1-1 by mistake, stay on the line and speak with the dispatcher telling them it was in error. If you hang up, prepare for the dispatcher to call you back. If you do not answer, a Law Enforcement Officer will be sent to your location to determine that everything is ok.

#### What information does the dispatcher need to send help?

The following is the minimum information needed for a response:

- Location of your emergency (exact address, intersection, or landmark)
- Type of emergency
- Your name and callback phone number in case we need further information

Why does the dispatcher need me to stay on the line after I have called for help?

- To ensure your safety and those involved
- In case a medical condition changes for the better or worse, so as to provide immediate assistance with instructions to help until medical crews arrive.
- Also, to provide current and accurate information to the responding units whether medical or law enforcement

#### Why do you ask so many questions?

Dispatchers follow a specific line of questioning to assist with rapid identification of the situation and collection of facts. Dispatchers do not ask these questions because they are nosy. Their primary concern is to obtain as much information as is possible to expedite the emergency response by the public safety agency and for the safety of the public and police or fire responders.

## If you can't decide if your call is an emergency, consider it to be an emergency and dial 911

## Commissioner of the Revenue Office Updates

## Personal Property:

- Questions about specific items listed on your personal property tax ticket should be directed to our office at (540) 980-7750, Monday Friday, 8:30am 5:00pm. Our Deputy Commissioners do not accept personal property tax payments.
- The "Motor Vehicle Property Tax Exemption for Disabled Veterans" took effect January 1, 2021. If you are a Veteran with a 100% service-connected disability, you may qualify for one vehicle exemption. - The pandemic is forecasted to cause an increase in vehicle values stemming from a low supply caused by auto factory shutdowns and reduced production. Fewer vehicles available to purchase as buyer demand increases will cause values to increase. Pulaski County uniformly uses the NDA clean trade-in value when assessing vehicles.

#### Real Estate:

- New Construction with a building permit finalized <u>by November 1, 2021</u>, will be assessed this year by the County Assessor. A change in assessment notice for this new construction will be sent to the taxpayer by the end of the year.
- Do you own five or more acres solely dedicated to farming? Land Use paperwork for new applicants may be obtained in our office and submitted by November 1 each year for evaluation of eligibility for the following year. Verifiable documentation of farming must be submitted with the application. A reduction of taxes based on use will be applied for those who qualify.
- Land Use for forest acreage of 20 acres or greater requires a Forest Management Plan (FMP) not older than 10 years and on file in our office by November 1, 2021, to remain in the land use program.
- ♦ Land owners in the land use program must report any changes in use within sixty(60) days.
