Amy Lewis, Chair, called the meeting to order at 8:30 a.m.

The Poll Worker List for 2022 was discussed and approved unanimously. Letters and forms will be mailed out to all prospective workers on this list. We will continue to work on enlarging our list of election officials.

After discussion on Redistricting and the need for a new Polling location for the new Precinct, a motion was made by Sybil Atkinson and seconded by Janet Johnson that Pulaski Elementary School be the location for our new Precinct. The motion passed unanimously.

Information was presented to the Board for the purchase of needed equipment for our new Precinct. Motion was made by Sybil Atkinson and seconded by Janet Johnson that the equipment for the new precinct be purchased as presented. The motion passed unanimously.

The need for an additional Expressvote machine was discussed. Motion by Sybil Atkinson and seconded by Janet Johnson to purchase the needed machine was passed unanimously.

Information was presented to the Board that battery replacements for all of our voting equipment is needed this maintenance cycle. Amy Lewis moved that the batteries be purchased, seconded by Janet Johnson and motion passed unanimously.

Our Capital Improvements Request has been approved for the purchase of new Electronic Poll Books. Motion by Janet Johnson and seconded by Amy Lewis to purchase the Electronic Poll Books from DemTech. The motion passed unanimously.

Recognizing that our scanning plans for Pulaski County Voting Records begun in 2016 are now complete: A motion was made by Amy Lewis and seconded by Janet Johnson and passed unanimously that "from here forward the Pulaski County Voting Records continue to be Electronic Records."

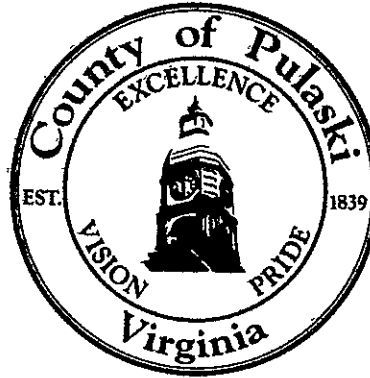
