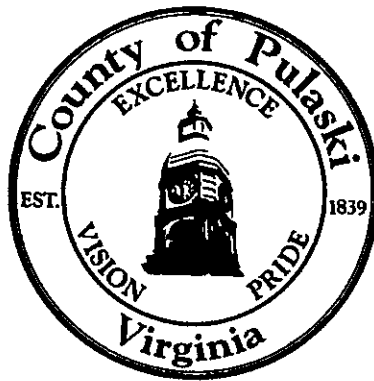

As required by the Code of Virginia, the Pulaski County Electoral Board met on March 4, 2020, at 9:04 a.m. in the Training Room/EOC adjacent to the Office of the Pulaski County Registrar for the purpose of canvassing the March 3, 2020 Democratic Presidential Primary Election. Persons present were: Amy Lewis, Chair, Janet Johnson, Vice Chair, Sybil S. Atkinson, Secretary, Maetta Crewe, Clerk of the Circuit Court, and Kathryn Webb, Registrar.

Motion was made by Sybil Atkinson to go into closed session for the purpose of the Provisional Ballot meeting and was duly seconded by Janet Johnson and passed unanimously.

Motion was made by Sybil Atkinson and seconded by Janet Johnson to reconvene their regular meeting and certified that only Provisional Ballot business was discussed by the Electoral Board while in closed session. The motion passed unanimously.

There were 2 Provisional Ballots received and 2 Ballots were counted.

All thirteen precincts were canvassed.

The meeting was recessed at 11:30 a.m. to wait for the paperwork to be prepared, and reconvened at 11:40 a.m. to complete the Canvass.

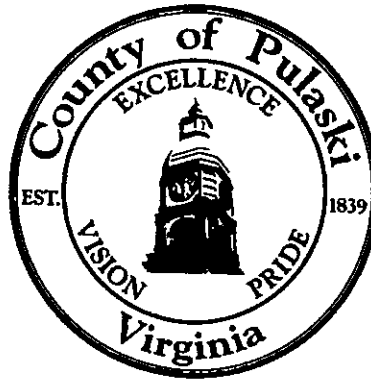
All votes were tabulated and certified. All necessary actions were completed and there being no discrepancies, reports were filed as required by law.
